FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

FIRM COMMENT: CUSTOMER PURCHASED A MUNICIPAL BOND FROM M&T SECURITIES, INC. THE SALE OF THE BOND WAS MADE BY RR TINA POWERS. AT THE TIME OF PURCHASE, THE BOND WAS SELLING AT A PREMIUM TO PAR. THE FIRM HAS OFFERED TO PLACE THE BOND FOR BIDS, BUT THE CUSTOMER HAS NOT RESPONDED TO THE OFFER. THE CLIENT RESPONDED ON JULY 10, 2014, THAT HE DOES NOT WISH TO PLACE THE BOND FOR BIDS AND HAD NO FURTHER QUESTIONS. REPRESENTATIVE COMMENT: AT THE TIME OF THIS COMPLAINT I WAS WORKING ON A TEAM WITH A 'JUNIOR FINANCIAL CONSULTANT'. IT WAS THIS JUNIOR FINANCIAL CONSULTANT WHO HAD SEVERAL CONVERSATIONS WITH THE CUSTOMER AND DESPITE NOT BEING PROPERLY LICENSED TO DISCUSS A MUNICIPAL BOND, THIS INDIVIDUAL DID JUST THAT AND OFFERED INCORRECT INFORMATION TO THE CUSTOMER ABOUT THEIR MUNICIPAL BOND. MY ONLY CONTACT WITH THE CUSTOMER WAS TO ANSWER HIS QUESTIONS DURING AN UNSOLICITED TELEPHONE INTERACTION WHEN THE NEW ISSUE MUNICIPAL BOND IN QUESTION WAS FIRST OFFERED. THE COMPLAINT WAS BASED SOLELY ON THE INCORRECT INFORMATION SUPPLIED BY THE JUNIOR FINANCIAL CONSULTANT. MY NAME WAS NOT SUBJECT OR MENTIONED WITHIN THE WRITTEN CUSTOMER COMPLAINT. I WAS INCLUDED IN THE DISCLOSURE BECAUSE I WAS THE SENIOR FINANCIAL CONSULTANT ON THE TEAM AND RECEIVED COMPENSATION FOR THE PROPERLY EXECUTED TRADE AS REQUESTED BY THE CUSTOMER ON AN UNSOLICITED BASIS. THE JUNIOR FINANCIAL CONSULTANT HAS SINCE LEFT THE FIRM. THE COMPLAINT WAS CLOSED AFTER THE CUSTOMER EDUCATED HIMSELF FURTHER AND DECIDED TO KEEP THIS MUNICIPAL BOND IN HIS ACCOUNT TO MATURITY.
