BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. 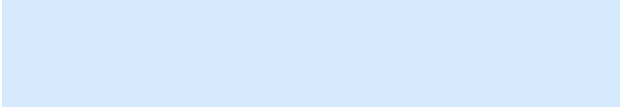

Allegations: CLIENTS CLAIM THEY SPENT \$400,000.00 PURCHASING THE METLIFE ANNUITY 7 YEARS AGO AND HAD ALWAYS BEEN GUARANTEED BY THE FA THE WOULD GET THEIR ORIGINAL INVESTMENT OF \$400,000.00 BACK IN SEVEN YEARS. THEY WERE TOLD THEY WOULD EARN 5% ANNUALLY IN WHICH THEY WOULD BE PAID MONTHLY, THEN AT THE END OF THE SEVEN YEARS THEY WOULD GET THEIR ENTIRE ORIGINAL INVESTMENT BACK, MAYBE MORE IF THE MARKET WAS FAVORABLE. CLIENT CLAIMS THEY HAVE NOW LEARNED FROM THEIR NEW FA THERE IS NO SUCH PRODUCT AND THEY DO NOT HAVE A GUARANTEE TO GET THEIR \$400,000.00 BACK, PARTICULARLY SINCE THEY HAVE BEEN TAKING WITHDRAWALS FOR SEVEN YEARS AND IT IS A VARIABLE CONTRACT. THE NEW FA CALLED THE PREVIOUS FA WHO SOLD THE CONTRACT TO THE CLIENTS TO ASK HIM ABOUT IT. THE PREVIOUS FA TOLD THEM THEY MUST HAVE MISUNDERSTOOD. CLIENTS CLAIM THERE IS NO MISUNDERSTANDING AND THEY WERE TOLD THIS WAS GUARANTEED FOR SEVEN YEARS AND WANT A RESOLUTION TO THIS. FILING REQUIRED, OVER \$5,000.00.

OUR RECORDS REFLECT TWO SEPARATE ANNUITIES WERE PURCHASED. THE FA HAS INDICATED THE CLIENT WAS NEITHER INFORMED THE ANNUITIES WOULD PAY INCOME IN THE AMOUNT OF 5% NOR THAT THE FULL PRINCIPAL AMOUNT INVESTED IN EACH OF THE ANNUITIES WOULD BE RETURNED TO YOU AFTER A PERIOD OF SEVEN YEARS. IT IS UNDERSTOOD THE ANNUITIES WERE PURCHASED WITH A LIFETIME INCOME SOLUTION (LIS) RIDER. THIS RIDER PROVIDES THE OPPORTUNITY TO WITHDRAW UP TO 5% (ANNUALLY) OF THE INCOME BASE AS WELL AS THE ABILITY TO LOCK IN A GUARANTEED MINIMUM LIFETIME INCOME REGARDLESS OF PERFORMANCE. THE CLIENT BEGAN TAKING WITHDRAWALS SHORTLY AFTER THE PURCHASES. SINCE THE ANNUITIES WERE PURCHASED, THE CLIENT HAS RECEIVED STATEMENTS FROM METLIFE AND EDWARD JONES. THE METLIFE STATEMENTS REFLECT THE ACCOUNT BALANCE, THE DEATH BENEFIT AND THE GUARANTEED INCOME BENEFIT BASE. OUR RECORDS REFLECT THE ANNUITIES WERE DELIVERED TO YOU AS EVIDENCED BY THE SIGNED DELIVERY RECEIPTS. IN ADDITION, YOU SIGNED PURCHASE CONFIRMATION AND ACKNOWLEDGEMENT FORMS FOR EACH OF THE ANNUITIES. THE FA HAS HAD MULTIPLE ACCOUNT REVIEWS AND CONVERSATIONS WITH THE CLIENT SINCE 2004 YET NEVER EXPRESSED A CONCERN UNTIL OCTOBER 2011. BASED ON OUR REVIEW, THERE WERE NO GUARANTEES MADE AS TO THE RETURN OF PRINCIPAL OR THE PERFORMANCE OF THE ANNUITIES. IN ADDITION, BASED ON DISCUSSIONS WITH THE FORMER FA AND THE CLIENT'S CURRENT FA, IT APPEARS THE ANNUITY (WITH THE INCOME RIDER) WILL ASSIST THE CLIENT IN MEETING YOUR INCOME NEEDS. IN REVIEWING THE PERFORMANCE OF THE ANNUITIES, IT APPEARS THERE HAVE BEEN NO LOSSES INCURRED. CLAIM DENIED.
