BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

ACCORDING TO THE FA AS WELL AS THE BRANCH OFFICE RECORDS, HE MET WITH THE CLIENT ON JUNE 9, 2008. THE FA HAS INDICATED, DURING THE MEETING, CONCERNS RELATED TO CURRENT MARKET CONDITIONS WERE DISCUSSED. THE FA HAS FURTHER INDICATED HE REITERATED THE FIRM'S BUY AND HOLD INVESTMENT PHILOSOPHY. IT IS UNDERSTOOD THEY ALSO DISCUSSED MONEY MARKET ACCOUNTS AS WELL AS THE FRANKLIN INCOME FUND. THE FA HAS STATED HE EXPLAINED EXCHANGES COULD BE COMPLETED WITHIN THE SAME FUND FAMILY WITHOUT INCURRING AN ADDITIONAL SALES CHARGE. AS A RESULT OF THEIR DISCUSSION, SHARES OF VARIOUS FRANKLIN TEMPLETON FUNDS HELD IN THE ACCOUNT WERE EXCHANGED TO THE FRANKLIN INCOME FUND. AT THE TIME OF THE EXCHANGES, THE CLIENT WOULD HAVE RECEIVED TRADE CONFIRMATIONS DETAILING THE TRANSACTIONS. IN ADDITION, THE EXCHANGES WOULD HAVE BEEN REFLECTED ON THE JUNE 2008 ACCOUNT STATEMENT. SINCE THE EXCHANGES WERE COMPLETED, THE CLIENT HAS RECEIVED STATEMENTS ON A MONTHLY BASIS WHICH HAVE REFLECTED THE SHARES OF FRANKLIN INCOME FUND BEING HELD IN THE ACCOUNT. ACCORDING TO OUR RECORDS, THE CLIENT SPOKE WITH THE FA IN SEPTEMBER 2008 AT WHICH TIME THE INVESTMENT AS WELL AS THE CLIENTS CONCERNS RELATED TO THE MARKET WERE DISCUSSED. AT THAT TIME, IT IS UNDERSTOOD THE FA ENCOURAGED THE CLIENT TO STAY INVESTED AND THE CLIENT AGREED. BASED ON OUR REVIEW, IT IS OUR OPINION THE AFOREMENTIONED TRANSACTIONS WERE COMPLETED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. THE TRANSACTIONS WERE EVIDENCED THROUGH TRADE CONFIRMATIONS AND ACCOUNT STATEMENTS. IN ADDITION, OUR RECORDS REFLECT SHARES OF FRANKLIN INCOME FUND WERE ORIGINALLY PURCHASED IN THE ACCOUNT ON FEBRUARY 13, 2007; THEREFORE, IT WOULD SEEM THE CLIENT WAS AWARE THAT THIS WAS NOT A MONEY MARKET FUND. CLAIM DENIED.
