BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

THE CLIENT'S HUSBAND DIED IN JANUARY 2006 AND THE CLIENT DID NOT RECEIVE HER HUSBAND'S PENSION OR AN INSURANCE SETTLEMENT.

Broker Statement

THE FA HAS INDICATED, IN HIS INITIAL CONVERSATION WITH THE CLIENT (NOW DECEASED), THE CLIENT INFORMED HIM THAT RETIRED AND/OR RETIRING CO-WORKERS HAD PURCHASED LIFE INSURANCE POLICIES WITH THEIR PENSION PAYMENT AND THAT HE WAS INTERESTED IN DOING THE SAME. THE FA HAS INDICATED HE DID NOT ADVISE THE CLIENT AS TO WHAT PENSION PAYOUT ELECTION HE SHOULD CHOOSE AND HE DID NOT ASSIST THE CLIENT IN COMPLETING THE REQUIRED PAPERWORK. A SPOUSAL BENEFICIARY WAIVER WOULD HAVE BEEN SELECTED ON THE PAPERWORK THAT WAS SUBMITTED DIRECTLY TO THE CLIENT'S FORMER EMPLOYER. IN REVIEWING ACCOUNT INFORMATION, IT APPEARS THE POLICY THAT WAS ISSUED WAS "RATED - TOBACCO" WHICH RESULTED IN THE PREMIUMS BEING MUCH HIGHER THAN ANTICIPATED. ACCORDING TO PROTECTIVE LIFE, THE POLICY WAS ORIGINALLY ISSUED (ON DECEMBER 15, 2005) WITH A 20 YEAR INITIAL PREMIUM PERIOD AND THE POLICY WAS REISSUED ON DECEMBER 19, 2005 WITH A 15 YEAR PREMIUM PERIOD. WHEN REVIEWING THE POLICY WITH THE CLIENT, THE FA EXPLAINED THE RATING AND THE HIGHER PREMIUM. IT IS UNDERSTOOD, BASED ON THEIR DISCUSSION, THE CLIENT INFORMED THE FA HE DID NOT WISH TO RETAIN THE POLICY; THEREFORE, PROTECTIVE LIFE WAS NOTIFIED THAT THE POLICY WAS NOT BEING ACCEPTED. WE CERTAINLY UNDERSTAND THE COMPLAINANT'S FRUSTRATION WITH THIS SITUATION; HOWEVER, IT SEEMS ALTHOUGH A POLICY WAS ISSUED, THE CLIENT DID NOT ACCEPT THE POLICY. IN ADDITION, ACCORDING TO PROTECTIVE LIFE, NO PREMIUM PAYMENTS WERE EVER MADE. FURTHER, IT DOES NOT APPEAR THE FA MADE ANY RECOMMENDATIONS AS TO WHAT PENSION PAYOUT OPTION THE CLIENT SHOULD SELECT. BASED ON OUR REVIEW, WE WOULD RESPECTFULLY DENY ANY REQUEST FOR COMPENSATION RELATED TO THIS MATTER.
