About BrokerCheck®



BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. THE CLIENT ALLEGES BECAUSE IF THE IR HAD PURCHASED SHARES OF BNI, HIS IRA VALUE WOULD HAVE INCREASED BY APPROXIMATELY \$26,000.00.

ACCORDING TO OUR RECORDS, THE CLIENT'S ACCOUNT WAS TRANSFERRED TO EDWARD JONES IN AUGUST 2004. THE IR HAS INDICATED HE PROVIDED A PROPOSAL TO THE CLIENT CONSISTING OF A DIVERSIFIED ALLOCATION OF AMERICAN FUNDS. HOWEVER, THE CLIENT PROMPTLY INFORMED THE IR, HE INTERESTED ONLY IN INDIVIDUAL STOCKS. THE IR HAS STATED HE THEN PREPARED A PROPOSAL FOR THE CLIENT CONSISTING OF VARIOUS INDIVIDUAL STOCKS. IT IS UNDERSTOOD THE CLIENT INFORMED THE IR HE WANTED TO INVEST ALL OF THE FUNDS IN BURLINGTON NORTHERN SANTA FE (BNI). THE IR HAS FURTHER INDICATED HE INFORMED THE CLIENT HE WAS NOT COMFORTABLE WITH INVESTING ALL THE FUNDS IN ONE STOCK AND EXPLAINED THE BENEFITS OF DIVERSIFICATION. IT IS UNDERSTOOD THAT, AFTER DISCUSSING THE COMMISSIONS ASSOCIATED WITH THE PURCHASE, THE CLIENT CEASED CONTACT WITH THE IR. THE ACCOUNT WAS TRANSFERRED TO ANOTHER FIRM ON OCTOBER 25, 2004. BASED ON OUR REVIEW, IT APPEARS THE IR HANDLED THIS SITUATION IN AN APPROPRIATE MANNER. THE IR DID NOT REFUSE TO PLACE THE ORDER TO PURCHASE BNI AND THE CLIENT APPARENTLY DECIDED NOT TO MAKE THE PURCHASE AFTER COMMISSIONS WERE DISCLOSED TO HIM. CLAIM DENIED.
