BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

UPDATE - THIS DISCLOSURE IS NO LONGER REPORTABLE ON THE CURRENT U4 BECAUSE IT WAS FILED MORE THAN 24 MONTHS AGO AND DID NOT SETTLE FOR \$10,000 OR MORE I DENY THE ALLEGATIONS. TO THE CONTRARY THE INVESTMENTS INSIDE THE ANNUITY WERE CHANGED IN OCTOBER, 2004 AS A DIRECT RESULT OF THE CLIENT'S COMPLAINT REGARDING THE PERFORMANCE OF THE ANNUITY. WE SAT TOGETHER AND WENT OVER THE PROPOSED CHANGE. THE CLIENT AGREED TO SUCH CHANGE AND WERE EXTREMELY HAPPY WITH THE PERFORMANCE OF THE INVESTMENT UNTIL THE LATEST DOWNTURN. HAD WE LIQUIDATED THE INVESTMENT THE CLIENT WOULD HAVE BEEN CHARGED A 7% CDSC AND THE INVESTMENT STILL WOULD LOST ADDITIONAL VALUE IN THIS MARKET. HAD I TURNED THE INVESTMENT OVER I WOULD HAVE REALIZED A SUBSTANTIAL COMMISSION ON SUCH A TRANSACTION THAT WOULD NOT HAVE BEEN IN THE CLIENT'S BEST INTEREST. IN ADDITION OVER \$14000 WAS WITHDRAWN FROM THE CONTRACT TO SATISFY REQUIRED MINIMUM DISTRIBUTIONS. AS TO TOTAL ACCOUNT VALUE OF THE ENTIRE PORTFOLIO, THE CLIENT IS SUBSTANTIALY AHEAD AS THEY HAVE WRITTEN CHECKS FOR OVER \$70000 FROM THEIR OTHER ACCOUNTS AS WELL THAT THE CLIENTS DO NOT WISH TO ACKNOWLEDGE AS PART OF THEIR RETURN.
