BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. ACCORDING TO THE FA, THE CLIENT IS NOT IN GOOD HEALTH; THEREFORE, WE ARE RESPONDING DIRECTLY TO THE POA. IN HER CORRESPONDENCE, THE CLIENT HAS EXPRESSED A CONCERN RELATED TO CHANGES MADE TO THE ACCOUNT IN MARCH AND APRIL OF 2009. THE FA HAS INDICATED HE SUGGESTED CHANGES TO THE PORTFOLIO ALLOCATION BASED ON HIS DISCUSSIONS WITH THE CLIENT ABOUT REPOSITIONING THE ACCOUNT(S) TO MORE CONSERVATIVE, INCOME PRODUCING INVESTMENTS. AS A RESULT OF THEIR DISCUSSIONS, THE HARTFORD LEADERS SOLUTION ANNUITY WAS SURRENDERED AND THE MUTUAL FUNDS WERE LIQUIDATED. THE FA HAS INDICATED HE SUGGESTED THAT THE PROCEEDS FROM THE SURRENDER/LIQUIDATIONS BE UTILIZED TO PURCHASE FIXED INCOME INVESTMENTS. THE FA HAS FURTHER INDICATED THE CLIENT AGREED WITH HIS SUGGESTIONS AND EXPRESSED NO CONCERNS UNTIL APPROXIMATELY THREE MONTHS AFTER THE TRANSACTIONS WERE COMPLETED. AT THAT TIME, THE FA REMINDED THE CLIENT THAT WHEN THE TRANSACTIONS WERE COMPLETED IN MARCH AND APRIL OF 2009, SHE WAS VERY CONCERNED ABOUT THE PROTECTION OF PRINCIPAL AS WELL AS THE INCOME TO BE RECEIVED FROM THE INVESTMENTS. BASED ON OUR REVIEW, IT IS OUR OPINION; THE TRANSACTIONS EFFECTED IN THE ACCOUNT WERE COMPLETED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. ALTHOUGH THE VALUES OF THE INVESTMENTS HELD IN THE ACCOUNT WILL FLUCTUATE, INTEREST IS CALCULATED AND PAID ON THE PRINCIPAL AMOUNT(S).
