BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Broker Statement SHORTLY AFTER TRANSFERRING HIS ACCOUNT TO US, THE CLIENT REQUESTED MULTIPLE TIMES THAT I REVIEW THE ANNUITY CONTRACTS FOR SUITABILITY OF HIS CURRENT GOALS AND OBJECTIVES. IT WAS DETERMINED BY HIM AND HIS DAUGHTER THAT THE BENEFIT OF THE ANNUITY DID NOT OUTWEIGH THE COST OF THE M&E AND WAS BEYOND ANY SURRENDER PERIOD. THE CONTRACTS HAD APPRECIATED BACK TO THE ORIGINAL PREMIUM PAYMENT WITH SOME GROWTH. HIS GOAL WAS



PRESERVATION OF CAPITAL TO TRANSFER TO HIS HEIRS, AND HE WANTED MINIMAL EXPOSURE TO THE STOCK MARKET. THE CLIENT FORGOT AND DID NOT MENTION THAT THERE HAD BEEN A 1035 EXCHANGE INTO THE CURRENT CONTRACTS. THE ANNUITY COMPANIES SUPPLIED THE PREMIUM PAYMENTS NOT THE COST BASIS, (MISCOMMUNICATION ON MY ASSISTANT'S PART AT THE TIME OF REQUEST). SO THE SURRENDER TO THE VA INTO A CD HAD A LARGER TAX CONSEQUENCE THAN EXPECTED DUE TO THE MUCH LOWER COST BASIS.
