BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. WE ARE PROVIDING INFORMATION TO THE COMPLAINANT RELATED TO THE SPECIFIC TRANSACTION IN QUESTION AS A REGISTERED OWNER OF THE BOND IN QUESTION. ACCORDING TO THE IR, THE COMPLAINANT'S WIFE CONTACTED HIM ABOUT SELLING THE BOND IN ORDER TO PAY FOR HER DAUGHTER'S HIGH SCHOOL TUITION. WHEN THE BOND WAS PRESENTED FOR DEPOSIT, IT WAS DETERMINED BOTH OF THE REGISTERED ACCOUNT OWNERS WOULD BE REQUIRED TO SIGN THE BOND FOR NEGOTIABILITY. IT IS UNDERSTOOD THE COMPLAINANT'S WIFE INFORMED THE BRANCH OFFICE STAFF SHE WOULD HAVE THE COMPLAINANT SIGN THE BOND AND RETURNED AT A LATER DATE WITH BOTH SIGNATURES. THE CERTIFICATE WAS DEPOSITED IN THE ACCOUNT AND PURSUANT TO INSTRUCTIONS RECEIVED FROM THE COMPLAINANT'S WIFE (AS THE CUSTODIAN OF THE EDWARD JONES ACCOUNT) THE BOND WAS SOLD AND THE PROCEEDS RELEASED. OUR RECORDS REFLECT TWO CHECKS WERE ISSUED FROM THE ACCOUNT BOTH ON 4/3/06 ONE OF THE CHECKS WAS SENT REGULAR MAIL AND ONE OF THE CHECKS WAS OVERNIGHTED TO THE ADDRESS OF RECORD. THE CHECK THAT WAS SENT REGULAR MAIL WAS SUBSEQUENTLY STOPPED. BOTH CHECKS WERE ISSUED AS THE ACCOUNT WAS REGISTERED. BASED ON OUR REVIEW, THE BRANCH OFFICE STAFF AS WELL AS THE FIRM RELIED ON WHAT WE BELIEVED WERE VALID SIGNATURES FROM THE REGISTERED BONDHOLDERS. AND, IT APPEARS THE BRANCH OFFICE STAFF WAS INFORMED THAT THE FUNDS WERE TO USED FOR THE BENEFIT OF THE MINOR. CLAIM DENIED.
