- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

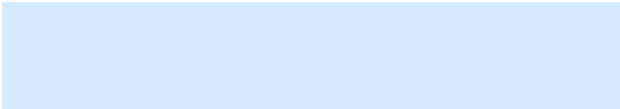

THE CLIENT INDICATES THAT WHEN SHE QUESTIONED THE FINANCIAL ADVISOR ABOUT THE PREMIUMS, SHE WAS TOLD SHE DID NOT HAVE TO PAY ANY ADDITIONAL PREMIUMS. THE FIRM'S REVIEW OF THE MATTER REVEALS THE CLIENT RECEIVED THE POLICIES AND ILLUSTRATIONS DETAILING THE SUBACCOUNT INVESTMENT OPTIONS FOR EACH POLICY, THE PREMIUMS TO BE CONTRIBUTED AND THE ILLUSTRATED GROWTH. WHILE THE CLIENT PAID THE EXPECTED PREMIUMS AS OUTLINED IN THE POLICY, THE POLICY VALUES HAVE DECREASED OVER TIME DUE TO MARKET FLUCTUATIONS. THE CLIENT IS NOT REQUIRED TO PAY ANY ADDITIONAL PREMIUMS INTO THE POLICIES AND AT THIS TIME THE POLICIES REMAIN IN FULL FORCE AND EFFECT. THE CLIENT EXPRESSED SEPARATE CONCERNS ABOUT THE SELECTION OF THE THIRD PARTY ADMINISTRATOR ("TPA") OF HER HUSBAND'S 401K PLAN. THE CLIENT SOUGHT INPUT RELATED TO TPA OPTIONS FROM TWO BROKERAGE FIRMS. THE EDWARD JONES FINANCIAL ADVISOR INFORMED THE CLIENT THAT HE COULD NOT WORK WITH AN ADVISOR FROM ANOTHER FIRM. THE CLIENT MADE THE DECISION TO CONTINUE TO WORK WITH THE EDWARD JONES FINANCIAL ADVISOR UNTIL HE MOVED TO A DIFFERENT BRANCH OFFICE, AT WHICH TIME THE RELATIONSHIP TERMINATED. BASED ON THE FIRM'S REVIEW OF THIS MATTER NO RENUMERATION WAS OFFERED TO THE CLIENT AND NO FURTHER ACTION WILL BE TAKEN.
