BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

WHEN IN PREMIER BANKING, AS A PREMIER CLIENT MANAGER (PCM), THE DUTIES I WAS CHARGED WITH AND WHICH MY PERFORMANCE WAS BASED ON, WAS TO PROVIDE INTRODUCTIONS TO FINANCIAL ADVISOR (FA) OF EXISTING BANKING CLIENTS. WHEN A CLIENT WANTED TO EXPLORE ADDITIONAL OPTIONS, MY OBJECTIVE WAS TO ASSESS THE CLIENT'S WILLINGNESS TO MEET WITH AN FA, NOT TO PROVIDE ANY SALES OR PRODUCT ADVICE. IN MY ROLE AS A PCM, I DID NOT REPRESENT MYSELF OR ANY PRODUCTS AS ALLEGED IN THE COMPLAINT. THIS MATTER INVOLVES THE SALE OF AUCTION RATE SECURITIES (ARS). THE TRANSACTION(S) AT ISSUE TOOK PLACE BEFORE MID-FEBRUARY 2008, WHEN THE ARS MARKET SUFFERED WIDESPREAD AUCTION FAILURES AND ILLIQUIDITY. THE FINANCIAL ADVISOR DID NOT CAUSE, CONTRIBUTE OR HAVE ANY CONTROL WHATSOEVER OVER THESE MARKET EVENTS. THE FIRM REACHED AGREEMENT WITH CERTAIN OF ITS REGULATORS, PURSUANT TO WHICH IT REPURCHASED ARS FOR THEIR FULL PAR VALUE FROM CERTAIN CLIENTS, INCLUDING THE INSTANT CLIENT, WHERE THEY COMPLAINED OR NOT. THE FINANCIAL ADVISOR WAS NOT A PARTY TO THAT AGREEMENT, DID NOT MAKE ANY PAYMENT TO THE CLIENT, AND WAS NOT ASKED TO AND DID NOT CONTRIBUTE TO THE REPURCHASE AMOUNT. THIS MATTER WAS PREVIOUSLY SETTLED WITH AN AMOUNT THAT REFLECTED THE PAR VALUE OF THE REPURCHASED ARS, AS REQUIRED BY FINRA REGULATORY NOTICE 09-12. FINANCIAL ADVISOR WAS NOT PREVIOUSLY NAMED IN PRIOR COMPLAINT. AFTER RECEIVING THE SETTLEMENT, THE CLAIMANT FILED AN ARBITRATION WITH ALLEGATIONS AGAINST THE SPECIFIC FINANCIAL ADVISOR.
