BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: CLIENT CLAIMS HE WAS CONTACTED REGARDING GETTING IN ON AN IPO FOR VISA (V) WHICH WOULD OCCUR IN MID MARCH, 2008. CLIENT CLAIMS HE WAS INFORMED THE STOCK WAS GOING PUBLIC ON 3/17/08 AND CLIENT WAS INFORMED HE WOULD HAVE TO HAVE THE MONIES IN THE ACCOUNT TO COVER THE COST IF HE OBTAINS SHARES AND A CHECK WAS DELIVERED FOR \$120,000. CLIENT CLAIMS HE INFORMED THE FA HE WOULD NOT PAY MORE THAN \$58.00 PER SHARE ON THE TRANSACTION. CLIENT CLAIMS HE LATER LEARNED HE DID NOT RECEIVE SHARES AND BELIEVES, DUE TO INFORMTION HE RECEIVED, THAT THE FA DIDN'T EVEN PLACE THE ORDER. CLIENT CLAIMS HIS REQUEST TO SEND HIS FUNDS BACK WAS IGNORED. CLIENT BELIEVES HIS ORDER SHOULD BE PROCESSED TO PURCHASE SHARES AT \$58.00 (2,068 SHARES) AND THEN SOLD AT \$68.00. CLAIM EXCEEDS \$5,000.

FA STATED HE HAD SEVERAL CONVERSATIONS WITH CLIENT REGARDING THE PURCHASE OF V AND IT WAS DETERMINED THE ORDER WOULD BE PLACED TO PURCHASE 2200 SHARES AT \$50.00 A SHARE OR BETTER AND THE ORDER WAS PLACED AT CLIENT'S DIRECTION. ACCORDING TO FA, A PURCHASE PRICE OF \$58.00 WAS NEVER DISCUSSED. FA STATED CLIENT DID INITIALLY CONSIDER THE PRICE OF \$56 OR BETTER BUT, ON THE DATE THE ORDER WAS PLACED, IT WAS DETERMINED THE ORDER WOULD BE ENTERED AT THE PRICE OF \$50 OR BETTER (BASED ON THE NUMBER OF SHARES CLIENT WANTED TO PURCHASE AND AMOUNT HE WISHED TO SPEND). I HAVE BEEN INFORMED BY OUR EQUITY TRADING DEPARTMENT THE STOCK BEGAN TRADING ON 3/19/08 AT OVER \$59 AND CLOSED THAT DAY AT \$56.50. IT IS MY UNDERSTANDING THE STOCK PRICE NEVER DROPPED TO THE PRICE OF \$50.00 A SHARE AND, THEREFORE, THE ORDER NEVER TRIGGERED AND DID NOT FILL. AS A RESULT, IT DOES NOT APPEAR CLIENT WOULD HAVE PURCHASED THE STOCK ON THE DATE IN QUESTION AND EDWARD JONES RESPECTFULLY DENIES ANY REQUEST FOR THE REIMBURSEMENT OF LOSSES ASSOCIATED WITH THIS MATTER. IN ADDITION, IT IS THE POLICY OF EDWARD JONES TO HAVE FUNDS AVAILABLE IN THE ACCOUNT FOR AN ORDER TO BE ACCEPTED FOR A STOCK TRADE OVER \$100,000. FA STATED HE DID DISCUSS OPTIONS REGARDING THE FUNDS DEPOSITED IN THE ACCOUNT AS CLIENT WAS AWARE OF THE TIME INVOLVED BEFORE THE FUNDS COULD BE SENT BACK TO CLIENT. OUR RECORDS INDICATE THE FUNDS (INCLUDING ANY INTEREST ACCRUED) WERE MAILED OVERNIGHT (AS DIRECTED) ON 3/26/08. AN OVERNIGHT FEE OF \$12.00 WAS CHARGED. ALL ACTIVITY WILL BE REFLECTED ON MARCH 2008 CUSTOMER ACCOUNT STATEMENT. IT DOES APPEAR THE BRANCH OFFICE DID PLACE THE ORDER IN ACCORDANCE WITH CLIENT'S INSTRUCTIONS AND THE FUNDS WERE REQUESTED TO BE DEPOSITED PURSUANT TO OUR POLICIES. CLAIM DENIED.
