BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

| <b>Broker Statement</b>  | I had placed a trade with the client on the line with Citigroup's internal department with the client's permission. The trade was for BITCF stock which the client owned         |



and wanted to sell his position in a limited order. With the client on the line I called my internal department at Citi to make the trade. While on the phone the client and the Citi representative I ask if the trade had executed, she said "yes." So I repeated that information back and the client was told the trade had went through and the order was completed. The following day the order was still standing and the trade was not completed. The client was in the right and was given the trade error as the representative in the internal department was wrong. There was also an NDA I received in an email which Citi had a concern with regarding an OBA issue which I was never confirmed of any wrong doing on any part of my employment at Citigroup.
