BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

OUR RECORDS REFLECT THE ACCOUNT WAS ESTABLISHED IN AUGUST 2004 AND IN SEPTEMBER 2004, VARIOUS AMERICAN FUNDS WERE PURCHASED. IN SEPTEMBER 2004, THE CLIENT SIGNED A SWITCH LETTER/REPOSITIONING OF ASSETS IN WHICH HE INDICATED FUNDS WERE BEING MOVED FROM A HARTFORD ANNUITY TO AMERICAN FUNDS DUE TO POOR PERFORMANCE. THE CLIENT ALSO SIGNED A LARGE ONGOING ACCOUNT WITHDRAWAL LETTER IN WHICH THE CLIENT ACKNOWLEDGED HIS UNDERSTANDING THAT CONTINUING TO WITHDRAW FUNDS IN EXCESS OF THE AMOUNT OF THE CURRENT RATE OF INCOME AND/OR RETURN WOULD RESULT IN A LOSS OF PRINCIPAL VALUE. BRANCH OFFICE RECORDS REFLECT THE FA HAS CONTACTED THE CLIENT ON MULTIPLE OCCASIONS REGARDING THE ACCOUNT AND IT APPEARS CHANGES WERE MADE TO THE PORTFOLIO ALLOCATION IN MAY 2006. AT THE TIME OF THE AFOREMENTIONED TRANSACTIONS, THE CLIENT WOULD HAVE RECEIVED TRADE CONFIRMATIONS. IN ADDITION, ACCOUNT STATEMENTS PROVIDE INFORMATION REGARDING THE INVESTMENTS HELD IN THE ACCOUNT AS WELL AS REFLECTING ALL ACCOUNT ACTIVITY. BASED ON OUR REVIEW, IT IS OUR OPINION ALL TRANSACTIONS EFFECTED IN THE ACCOUNT WERE COMPLETED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. IN ADDITION, IT DOES NOT APPEAR THE INVESTMENTS PURCHASED AND/OR HELD IN THE ACCOUNT ARE OUTSIDE THE ACCOUNT OBJECTIVES. AS A RESULT OF OUR REVIEW, WE WILL BE MAKING NO ADJUSTMENTS TO THE ACCOUNT IN REGARD TO THIS MATTER. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT RELATED TO THE DECLINE IN THE VALUE OF THE ACCOUNT, IT APPEARS THE INVESTMENTS HAVE PERFORMED FAIRLY WELL WHEN TAKING INTO CONSIDERATION THE WITHDRAWALS AND MARKET FLUCTUATION AS WELL AS CURRENT MARKET CONDITIONS. CLAIM DENIED.
