BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

**Allegations:** 1/8/09-7/15/08; THE CLIENT STATES THE FA INFORMED HIM THERE WOULD BE A SERVICE CHARGE OF \$1500 FOR HIS FUNDS TO BE MANAGED. THE CLIENT STATES THE FA SIMPLY LEFT HIS FUNDS AT THE AMERICAN FUND COMPANY. HE STATES THIS IS WHERE HIS MONEY WAS PRIOR TO MOVING HIS FUNDS TO THE FIRM. HE STATES THE FA ADVISED HIM TO LEAVE HIS FUNDS IN THE INVESTMENTS WHEN THE VALUE WAS DECLINING; HE DID NOT RECOMMEND ADJUSTING THE STRATEGY. HE STATES HE FINALLY LIQUIDATED THE ACCOUNT AND CASHED OUT HIS 401K AND INCURRED ADDITIONAL TAXES. THE CLIENT STATES HE IS OUT \$13700 DUE TO MARKET LOSSES, TAXES AND SALES CHARGES.

OUR RECORDS INDICATE THE CLIENT INVESTED \$30,273.97 IN AMERICAN FUNDS; THE CLIENT HAS INDICATED HE WAS INFORMED OF THE SALES CHARGES ON THESE INVESTMENTS. THE CLIENT RECEIVED A \$25,000 BREAKPOINT, A REDUCED SALES CHARGE. THE FA STATES HE REVIEWED THE INVESTMENT NEEDS AND OBJECTIVES BASED ON THE CLIENT'S AGE, RISK TOLERANCE AND TIMEFRAME. THE FUNDS PURCHASED WERE LONG TERM INVESTMENTS; THE FA INDICATES HE RECOMMENDED HOLDING THE FUNDS. IT IS OUR UNDERSTANDING THE CLIENT REQUESTED THE LIQUIDATION OF THE AMERICAN FUNDS AFTER SIX MONTHS TO HELP PAY DOWN DEBT. THE FA INDICATES HE INFORMED THE CLIENT OF THE 10% IRS PENALTY AND THE ADDITIONAL TAX IMPLICATIONS ON THE WITHDRAWAL FROM THE IRA ACCOUNT. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT WITH THE PERFORMANCE OF THE INVESTMENTS, THE PERFORMANCE IS ATTRIBUTED TO CIRCUMSTANCES BEYOND OUR CONTROL AND MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. UPON REVIEW OF THE INVESTMENTS WITHIN THE ACCOUNT, THEY APPEAR TO BE WITHIN THE SCOPE OF THE ACCOUNT INVESTMENT OBJECTIVES.
