BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. OUR RECORDS INDICATE THE BOND WAS PURCHASED IN THE CLIENT'S ACCOUNT ON MARCH 4, 2004. THE CLIENT WAS SENT A CONFIRMATION AND A PROSPECTUS AT THE TIME OF PURCHASE. THE LEHMAN BROTHERS HOLDINGS INC NOTES HAS REFLECTED ON THE MONTHLY STATEMENT FROM THE TIME IT WAS PURCHASED. OUR RECORDS INDICATE THE CLIENT RECEIVED A MONTHLY INTEREST PAYMENT FROM APRIL 2004 UNTIL SEPTEMBER 2008. WE HAVE BEEN IN CONTACT WITH THE FINANCIAL ADVISOR REGARDING THE PURCHASE OF THE LEHMAN BROTHERS HOLDINGS INC NOTES. IT IS OUR UNDERSTANDING THE CLIENT AUTHORIZED THE PURCHASE OF THE BOND. ACCORDING TO THE FA, THE CLIENT WANTED THE INTEREST THE BOND WAS PAYING AT THE TIME OF THE PURCHASE. BASED ON OUR REVIEW, IT APPEARS THE CLIENT WAS AWARE THE LEHMAN BROTHERS HOLDINGS INC NOTES WAS PURCHASED IN THE ACCOUNT ON MARCH 4, 2004. THE CLIENT WAS SENT A CONFIRMATION, PROSPECTUS, MONTHLY STATEMENTS AND 1099S REFLECTING THE INTEREST PAID ON THE BOND. WHILE WE UNDERSTAND THE CLIENT'S FRUSTRATION WITH THE PERFORMANCE OF THE BOND, THE PERFORMANCE IS BASED ON CIRCUMSTANCES BEYOND OUR CONTROL AND MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. IN LIGHT OF THESE CIRCUMSTANCES THE CLIENT'S REQUEST FOR REIMBURSEMENT OF THE LOSSES ON THE BOND IS RESPECTFULLY DENIED.
