BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. IR INDICATED HE DISCUSSED ALL DETAILS OF THE FUNDS TO INCLUDE ALL FEES/COMMISSIONS ASSOCIATED WITH THE "A" SHARES AND PRESENTED THE PROSPECTUSES IN WHICH HE REVIEWED SPECIFICALLY THE SECTION ON FEE STRUCTURES. ACCORDING TO LETTER, CLIENTS HAVE INDICATED THEY WERE IN RECEIPT OF THE PROSPECTUSES. ACCORDING TO IR, CLIENTS DID HAVE AN UNDERSTANDING OF OTHER SHARE CLASSES ASSOCIATED WITH MUTUAL FUNDS AS OWNED OTHER MUTUAL FUND SHARE CLASSES ("C" SHARES) AT ANOTHER FIRM AND HAD PREVIOUSLY PURCHASED AN "A" SHARE FUND WITH IR. IR STATED THE "A" SHARES WERE PURCHASED WITH CLIENTS FULL UNDERSTANDING OF THE FEES AND WITH THEIR AUTHORIZATION. IR INDICATED HE WAS NEVER INFORMED CLIENTS WOULD ONLY BE WORKING WITH HIM FOR A LIMITED TIME (ONE YEAR WINDOW) AND REFERENCES A CONVERSATION DURING ONE OF LAST MEETINGS IN WHICH HE RECALLS CLIENTS STATING THEY DID NOT INTEND TO MOVE MONEY OUT OF EDWARD JONES. BASED ON OUR REVIEW, IT DOES APPEAR CLIENTS WERE AWARE OF THE SHARE CLASSES AND ASSOCIATED FEES THROUGH CONVERSATIONS WITH IR, THE FUND PROSPECTUSES AND PREVIOUS INVESTMENTS HELD BOTH WITH EDWARD JONES AND OUTSIDE OF EDWARD JONES. ADDITIONALLY, IT DOES APPEAR ALL APPROPRIATE BREAKPOINTS (REDUCED COMMISSIONS) WERE APPLIED TO THE A SHARE PURCHASES. CLAIM DENIED.
