- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement	Mr. Ku denies the allegations that Hornor, Townsend & Kent ("HTK") alleged on his



Form U5, "violating firm policies by (1) overcharging clients for commission fees in excess of \$80,000; and (2) marked trades as unsolicited when trades were actually solicited" Mr. Ku's revenue over assets ("ROA") is far less than the industry average. In the course of a routine compliance exam, HTK found one liquidation where the trade was marked "unsolicited" and Mr. Ku subsequently self-reported another 10 or so, in all instances the clients had called in and requested liquidation of position(s) and he marked those unsolicited. Note: There are no customers complaining and no complaints anticipated from the allegations by HTK. Mr. Ku has 17 year history without any customer complaints. Mr. Ku intends to take this dispute to FINRA arbitration, then court, to have it removed from his record.
