BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. ACCORDING TO FA, WHEN CLIENT INITIALLY CONTACTED HIM IN EARLY 2007, HE REVIEWED CLIENT'S CURRENT INVESTMENT HOLDINGS AND ALSO DISCUSSED INVESTMENTS HE HELD IN THE PAST. FA INDICATED CLIENT INFORMED HIM HE HAD A LUMP SUM OF MONEY TO INVEST AND HE WAS LOOKING FOR THE HIGHEST RETURN IN A TAX FREE INVESTMENT. IT IS OUR UNDERSTANDING CLIENT WAS FAMILIAR WITH HIGH YIELD BOND FUNDS AS THE CLIENT HAD INFORMED FA HE WAS PREVIOUSLY INVESTED IN THE BLACK ROCK HIGH YIELD BOND FUND. FA INDICATED THE BLACK ROCK FUND WAS A TAXABLE FUND AND IN ORDER TO MEET CLIENT'S TAX FREE NEEDS, HE REVIEWED THE DETAILS OF THE ROCHESTER NATIONAL MUNICIPAL FUND. FA INDICATED HE DISCUSSED THE RISKS ASSOCIATED WITH THIS MUTUAL FUND INCLUDING MARKET FLUCTUATION AND HE INFORMED CLIENT THAT ALTHOUGH THE DIVIDEND WAS RELATIVELY STABLE BASED ON HISTORICAL PERFORMANCE, THE DIVIDEND WAS NOT GUARANTEED. IT IS OUR UNDERSTANDING AFTER FA REVIEWED THE DETAILS OF THE ROCHESTER FUND, CLIENT AUTHORIZED THE PURCHASE. IN ADDITION, FA INDICATED A PROSPECTUS WAS MAILED WITH THE TRADE CONFIRMATION, WHICH ALSO REFLECTED THE DETAILS OF THE MUTUAL FUND. GIVEN FA'S UNDERSTANDING THAT THE CLIENT IS FAMILIAR WITH HIGH YIELD MUTUAL FUNDS AND THE STATED INVESTMENT OBJECTIVES OF THE ACCOUNT INCLUDE AGGRESSIVE INCOME, IT APPEARS THIS MUTUAL FUND MET THE CLIENT'S INVESTMENT NEEDS. LASTLY, FA STATED CLIENT NEVER INFORMED HIM HE WAS A CONSERVATIVE INVESTOR OR HIS INVESTMENT FOCUS WAS PRESERVING PRINCIPAL. AS A RESULT OF OUR REVIEW, WE RESPECTFULLY DENY CLIENT'S REQUEST TO REIMBURSE THE FULL AMOUNT INVESTED INTO THE ROCHESTER NATL MUNI FUND IN FEBRUARY 2007.
