BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

THE PUTNAM FUNDS WERE SOLD ON DECEMBER 29, 2008. THE FA HAS INDICATED THAT HE SPOKE WITH THE CLIENT IN DECEMBER 2008 AND EXPLAINED THE FIRM'S RECOMMENDATION WITH REGARD TO PUTNAM FUNDS. BASED ON THEIR DISCUSSION, THE CLIENT MADE THE DECISION TO SELL THE INVESTMENTS. IT IS UNDERSTOOD THE PROCEEDS WERE UTILIZED TO PURCHASE VARIOUS INVESTMENTS. AT THE TIME OF THE TRANSACTIONS, THE CLIENT WOULD HAVE RECEIVED CONFIRMATIONS DETAILING THE TRADES. IN ADDITION, THE ACTIVITY WAS REFLECTED ON ACCOUNT STATEMENTS. IN REGARD TO THE ANNUITY, IT APPEARS THE TRANSFER BETWEEN HARTFORD LIFE AND AIG SUNAMERICA WAS COMPLETED AS A 1035 EXCHANGE. TO FACILITATE THE EXCHANGE, THE CLIENT COMPLETED AND SIGNED A REQUEST FOR TRANSFER/EXCHANGE FORM. IN ADDITION, OUR RECORDS REFLECT THE CLIENT SIGNED A TRANSFER OF ASSETS: ANNUITY TO VARIABLE ANNUITY LETTER ON MARCH 29, 2007 IN WHICH SHE ACKNOWLEDGED HER UNDERSTANDING THAT THE VALUE OF THE ANNUITY IS BASED ON THE PERFORMANCE OF THE UNDERLYING SUB-ACCOUNTS WHICH ARE SUBJECT TO MARKET FLUCTUATION. OUR RECORDS REFLECT THE AIG SUNAMERICA ANNUITY WAS ISSUED ON APRIL 17, 2007 AND THE CONTRACT WAS DELIVERED TO THE CLIENT ON APRIL 30, 2007. EXPLAINED WE UNDERSTAND THE CLIENT'S CONCERN RELATED TO THE DECLINE IN THE VALUE OF THE ACCOUNT; HOWEVER, MARKET FLUCTUATION IS A RISK ASSOCIATED WITH INVESTING. ALSO REMINDED THE CLIENT THAT WHILE THE VALUES OF THE FIXED INCOME INVESTMENTS HELD IN THE ACCOUNT MAY HAVE DECREASED, INTEREST IS CALCULATED AND PAID ON THE PRINCIPAL AMOUNT (NOT THE MARKET VALUE). CLAIM DENIED.
