- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

Based on the Customers' New Account Forms, Disclosure documents, and written and verbal communication, all trades were suitable and in alignment to stated investment objectives and risk tolerance. The investments at issue underwent appropriate product and customer-based suitability analysis, and the risks were discussed and disclosed, verbally and in writing. The allegations appear to be false and serve as a thinly disguised veil for "poor performance" which is no cause of action. Notes and broker representations reflect that Customer desired to invest internationally and diversify her family's finances away from the U.S. dollar, prior to ever contacting EPC. Being aware that the Firm specialized in the above strategy, Customer reached out to the Firm to invest internationally. Foreign markets and specific risks were discussed. Customer selected speculative investment objectives and long-term time horizons. There was no failure to disclose risks. Customers had authority, discretion and control of the accounts at all times. Customer authorization was obtained and documented prior to any trade. The allegations are patently false and the associated person may pursue all necessary and appropriate relief, including seeking expungement of the matter from the record.
