BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

LARSEN, THROUGH HIS ENTITY, RECEIVED DIVIDENDS TOTALING APPROXIMATELY \$48,000 FROM THE INITIAL \$94,000 INVESTMENT BUT NEITHER REMITTED NOR CREDITED ANY OF THE DIVIDENDS TO THE CUSTOMER. THE CUSTOMER DID NOT AUTHORIZE LARSEN TO USE ANY OF HIS FUNDS FOR LARSEN'S PERSONAL BENEFIT. LARSEN DEBITED APPROXIMATELY \$261,000 FROM THE CUSTOMER'S FIRM CHECKING ACCOUNT AND USED APPROXIMATELY \$255,000 TO ISSUE A BANK CHECK PAYABLE TO THE ENTITY HE OWNED AND CONTROLLED WHICH WAS NOT AN INVESTMENT FOR THE CUSTOMER'S BENEFIT AS REPRESENTED TO THE CUSTOMER. LARSEN USED A DEBIT CARD ASSOCIATED WITH HIS ENTITY TO MAKE PURCHASES FOR HIS BENEFIT TOTALING APPROXIMATELY \$72,000 WHICH



WAS FUNDED BY PROCEEDS FROM THE CUSTOMER'S FIRM CHECKING ACCOUNT AND WERE MADE WITH MONEY BELONGING TO THE CUSTOMER, WITHOUT THE CUSTOMER'S AUTHORIZATION. LARSEN FAILED TO RESPOND TO FINRA REQUESTS FOR DOCUMENTS.
