About BrokerCheck®



BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. HE STATES HE ASKED THE FA TO MANAGE HIS ACCOUNT PROFESSIONALLY IN CONJUNCTION TO HIS OBJECTIVES SO LOSS MAY BE MINIMAL SHOULD THE MARKET DECLINE. HE STATES HE WANTED TO BE CONTACTED WEEKLY ON THE ACTIVITIES OF HIS ACCOUNT. THE CLIENT STATES THE INVESTMENT ADVICE OF THE FA DID NOT BENEFIT HIM. ACCORDING TO THE CLIENT SURVEY, THE CLIENT WANTED TO BE CONTACTED MONTHLY; THE CLIENT ALSO COMPLETED A RISK TOLERANCE QUESTIONNAIRE. THE RISK TOLERANCE QUESTIONNAIRE INDICATED THE CLIENT HAD A MEDIUM TO HIGH RISK TOLERANCE. THE CLIENT APPEARED WILLING TO TAKE ON MORE RISK FOR A CHANCE TO EARN A HIGHER RETURN. THE FA CONTACTED THE CLIENT SEVERAL TIMES MONTHLY WITH EITHER RECOMMENDATIONS OR TO RESPOND TO INQUIRIES REGARDING POTENTIAL INVESTMENT OPPORTUNITIES. WHILE WE UNDERSTAND THE CLIENT'S FRUSTRATION WITH MISSING OUT ON POTENTIAL GAINS, THE FA INDICATES HE RECOMMENDED NOT INVESTING IN GENERAL MOTORS BECAUSE OF THE UNCERTAINTY IN THE INDUSTRY. RIMM WAS PURCHASED IN JUNE 2008. SINCE THAT TIME, THE FA INDICATES HE REVIEWED WITH THE CLIENT SEVERAL TIMES THE FLUCTUATION OF THE SECURITY AND THE RISKS, AS WELL AS THE POTENTIAL BENEFITS. BASED ON OUR REVIEW, IT APPEARS THE INVESTMENTS WERE WITHIN THE SCOPE OF THE CLIENT'S INVESTMENT OBJECTIVES - SHORT TERM, AGGRESSIVE SECURITIES. IT IS OUR UNDERSTANDING THE FA WAS IN CONTACT WITH THE CLIENT REGULARLY REGARDING HIS ACCOUNT AND POTENTIAL INVESTMENTS. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT WITH THE PERFORMANCE OF THE SECURITIES IN THE ACCOUNT, THE VALUE IS IS ATTRIBUTED TO CIRCUMSTANCES BEYOND OUR CONTROL AND MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. IN LIGHT OF THESE CIRCUMSTANCES, THE CLIENT'S REQUEST FOR REIMBURSEMENT IS RESPECTFULLY DENIED.
