About BrokerCheck®



BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

ACCORDING TO OUR RECORDS, THE ACCOUNT WAS ESTABLISHED IN MAY 2006. THE IR HAS INDICATED HE CONTACTED THE CLIENT AFTER RECEIPT OF THE TRANSFERRED FUNDS, CONFIRMED THE CLIENT'S INSTRUCTIONS FOR INVESTING AND PLACED THE TRADES TO PURCHASE THE MUTUAL FUNDS. THE IR HAS FURTHER INDICATED HE VISITED THE CORBIN, KY OFFICE ON MAY 17TH, AT WHICH TIME HE WAS INFORMED THEY HAD RECEIVED AN OVERNIGHT DELIVERY FROM THE CLIENT. IT IS UNDERSTOOD THE IR CONTACTED THE CLIENT TO QUESTION WHY THE CLIENT HAD CHANGED YOUR MIND ABOUT INVESTING THE FUNDS. APPARENTLY, THE CLIENT INFORMED THE IR THAT HIS PREVIOUS INVESTMENT REPRESENTATIVE HAD ADVISED THE CLIENT THAT THE SALES CHARGES ASSOCIATED WITH THE TRANSACTIONS EFFECTED IN THE ACCOUNT WERE APPROXIMATELY \$8,000.00. THE IR HAS STATED HE INFORMED THE CLIENT THAT WAS NOT CORRECT AND REITERATED HIS PREVIOUS DISCUSSION WITH THE CLIENT RELATED TO THE SALES CHARGES. HE HAS FURTHER INDICATED HE EXPLAINED THE FUNDS HAD BEEN INVESTMENTS PURSUANT TO THE CLIENT'S INSTRUCTIONS AND HE WAS ADVISED TO LEAVE THE FUNDS INVESTED. OUR RECORDS REFLECT PAPERWORK WAS SUBSEQUENTLY RECEIVED TO TRANSFER THE ACCOUNTS TO ANOTHER FIRM AND THE TRANSFER WAS COMPLETED ON JUNE 19, 2006

AT THE TIME OF THE PURCHASES, THE CLIENT RECEIVED TRADE CONFIRMATIONS WHICH PROVIDE INFORMATION REGARDING THE INVESTMENTS (TO INCLUDE SALES CHARGES). IN ADDITION, THE CLIENT RECEIVED THE APPROPRIATE PROSPECTUSES WHICH PROVIDE ALL DETAILS OF THE FUNDS. BASED ON OUR REVIEW, THE MUTUAL FUNDS WERE PURCHASED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. FURTHERMORE, IT APPEARS THE IR MADE THE APPROPRIATE DISCLOSURES RELATED TO THE SALES CHARGES ASSOCIATED WITH THE PURCHASES. THEREFORE, WE WILL BE MAKING NO ADJUSTMENTS TO THE ACCOUNT IN REGARD TO THIS SITUATION. CLAIM DENIED.
