BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at <https://www.adviserinfo.sec.gov>. In the alternative, you may search the IAPD website directly or contact your state securities regulator at <http://www.finra.org/Investors/ToolsCalculators/BrokerCheck/P455414>.

- **Are there other resources I can use to check the background of investment professionals?**

IT WOULD APPEAR FA ATTEMPTED TO OBTAIN INFORMATION ON COST BASIS IN ASSOCIATION WITH THE LIQUIDATION OF THE NATIONWIDE ANNUITY. IT WAS HIS INITIAL UNDERSTANDING THAT THERE WAS NO GAIN ON THE CONTRACT, HOWEVER, HE LATER LEARNED THAT THERE WAS A GAIN. NOTES ON CLIENT'S ACCOUNT AT THE TIME THE LIQUIDATION WAS PROCESSED (OCTOBER 2009) INDICATE THAT TAXES WERE DISCUSSED AND CLIENT WAS AWARE THERE WOULD BE A POTENTIAL TAX LIABILITY. WHILE WE UNDERSTAND CLIENT MAY NOT HAVE INTENDED TO INCUR THE TAX OBLIGATION ON THE LIQUIDATION OF THE NATIONWIDE ANNUITY AT ONE TIME, TAXES WOULD HAVE BEEN INCURRED BY CLIENT OR HER NAMED BENEFICIARIES IN THE FUTURE. EDWARD JONES WILL EXTEND AN OFFER TO PAY \$4,000.00 IN SETTLEMENT OF CLIENT'S CLAIM, SUBJECT TO THE TERMS AND CONDITIONS OF THE ENCLOSED SETTLEMENT AGREEMENT. THIS OFFER EXCEEDS THE HIGHEST LIKELY INCREASE IN CLIENT'S MARGINAL TAX RATE, MULTIPLIED BY THE AMOUNT DISTRIBUTED FROM THE CONTRACT. 8/12/11 RECEIVED EXECUTED SETTLEMENT OF CLAIM AND CHECK TO CLIENT WAS REQUESTED TO BE ISSUED AND MAILED TO THE ADDRESS OF RECORD.
