BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

ACCTS TRANSFERRED TO FA ON OR AROUND MAY 2007. AT TIME ACCTS TRANSFERRED TO FA, MAJORITY OF PORTFOLIOS WERE INVESTED IN MUTUAL FDS & ANNUITIES WITH GROWTH OBJECTIVES. FA STATED INITIAL MEETINGS REQUESTED IN 2007 WERE CANCELLED BY CLIENT AND CLIENT'S INITIAL INDICATION WAS EVERYTHING WAS FINE. FA INDICATED CLIENT WAS PROVIDED WITH RISK TOLERANCE QUESTIONNAIRE TO OBTAIN BETTER UNDERSTANDING OF OBJECTIVES. FA STATED SHE SUGGESTED CHANGES TO PORTFOLIOS TO DIVERSIFY INTO INCOME AND GROWTH & INCOME OBJECTIVES & CHANGES WERE MADE TO HOLDINGS. FA INDICATED & NOTES & E-MAILS CONFIRM, THEY WERE IN REGULAR CONTACT TO INCLUDE PERIOD OF TIME WHEN MKT BEGAN TO DROP IN FALL 2008. ACCORDING TO FA, IN FEB/MAR 2008 SHE WAS MADE AWARE CLIENT WAS CONTACTING AMERICAN FDS & THE HARTFORD DIRECTLY TO MAKE CHANGES TO ALLOCATIONS. FA STATED CHANGES BEING REQUESTED DID NOT APPEAR TO COINCIDE WITH LONG-TERM OBJECTIVES. FA STATED SHE AT NO TIME INFORMED CLIENT WAS SPENDING TOO MUCH TIME ON ACCTS. SHE STATED SHE DID INFORM CLIENT, BECAUSE OF CHANGES CLIENT WAS MAKING DIRECTLY, WAS DIFFICULT TO KEEP CLIENT ALLOCATED APPROPRIATELY OR TO GIVE BEST ADVICE. SHE STATED CHANGES WERE NOT FOLLOWING ORIGINAL PLAN & CLIENT AT NO TIME INDICATED A CHANGE TO STATED INVESTMENT OBJECTIVES. FA STATED SHE AT NO TIME REFUSED TO PLACE ORDERS AND INDICATED CLIENT HAD INQUIRED IN NOV 2008 ABOUT PURCHASING NO-LOAD MUTUAL FDS; HOWEVER, CLIENT WAS INFORMED SHE WAS UNABLE TO PLACE ORDERS TO BUY NO-LOAD FUNDS CLIENT HAD INTEREST IN THROUGH EDJ. IT DOES APPEAR FA WAS IN REGULAR CONTACT WITH CLIENT THROUGH MEETINGS, PHONE CONVERSATIONS AND E-MAILS TO INCLUDE THE FALL OF 2008. FURTHER, IT APPEARS CHANGES TO ACCTS WERE MADE IN EARLY 2008 IN AN EFFORT TO PROVIDE BETTER DIVERSIFICATION WITHIN ACCTS & FA WAS NOT MADE AWARE OF A DESIRE BY CLIENT TO CHANGE STATED INVESTMENT OBJECTIVES. CLAIM DENIED.
