- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

I had numerous meetings and created several financial plans for the client. One of the main concerns was coverage for Long Term Care for her as well as Retirement Income. She was concerned her existing policy did not provide enough coverage and she could not afford a second LTC policy. I explored the option of a 1035 annuity exchange which provided slightly less monthly income but provided extra income if she went into a qualified facility and she and I compared the two annuities with a side by side comparison, including costs, income difference, the 4 year surrender penalty, and discussed the requirements and limitations on the LTC benefit. I went so far as to include a representative from the annuity company to review the exchange and requirements with her. This review showed that the 1035 exchange was a suitable option for the client and her claim is unjustified. Other allegations regarding recommending to sell her home to justify the annuity exchange is totally false.
