FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Firm Statement

OUR RECORDS INDICATE THE POLICY IN QUESTION WAS PURCHASED IN SEPTEMBER 2008. OUR RECORDS ALSO INDICATE THE CLIENT SIGNED THE NECESSARY PAPERWORK FOR THE POLICY. THE FA INDICATES THE CLIENT WAS INTERESTED IN A HIGHER DEATH BENEFIT. THE APPLICATION WAS REVIEWED AND SIGNED. AT THE TIME THE POLICY WAS ISSUED, IT APPEARED TO MEET THE OBJECTIVE FOR A HIGHER DEATH BENEFIT AND LOWER PREMIUMS. IN THE LETTER TO HARTFORD, THE CLIENT WAS REQUESTING THE POLICY BE REINSTATED BECAUSE HE WAS NOT AWARE OF ANY TAXABLE GAINS ON THE POLICY. THE CLIENT ALSO STATED HE DID NOT UNDERSTAND THE PRODUCT AND WAS SOLD MORE LONG TERM COVERAGE INSURANCE THAN HE NEEDED. THE FA INDICATED THAT THE CHARGES FOR THE HIGHER DEATH BENEFIT WERE INCLUDED IN THE INTERNAL CHARGES, WHICH HE REVIEWED AT THE TIME THE POLICY WAS PRESENTED. OUR RECORDS FURTHER INDICATE THE CLIENT DECIDED TO TRANSFER HIS ACCOUNTS TO THE FA AT HIS NEW FIRM AT THE END OF 2008. IT IS OUR UNDERSTANDING THE CLIENT DID NOT HAVE ANY CONCERNS WITH THE POLICY UNTIL HE OPTED TO SURRENDER THE POLICY IN THE SUMMER OF 2010.
