- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement When the previous Advisor left the firm, this account was reassigned to me. The entire account consisted of SunTrust Index Linked Certificate of Deposits (SILC) which are FDIC insured CDs and provide 100% principal protection when held to maturity. After introducing myself to the client, she emphatically stated the only



type of investments she wanted in this account were SILCs because she wanted principal protection and FDIC coverage. She understood that during the term of the CD, market value fluctuates but if she waited till maturity, she would receive her principal guarantee. While I worked with her at SunTrust Investment Services, she invested in a few SILCs in addition to what she originally had before we met.

When I left SunTrust, one of the SILCs had an unrealized loss but it was still a few years away from maturity where her principal was 100% protected. She filed a complaint to be reimbursed for unrealized losses even though the CD was years away from maturity, her principal was fully protected at maturity, and she specifically requested only SILCs to be placed in her portfolio. SunTrust denied the complaint because again, it was a fully protected FDIC insured CD and exactly what she wanted.
