#### What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
  qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
  reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
  same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

**Broker Statement** 

I deny the allegations that have been alleged. First, all three accounts were discretionary managed accounts, which the client was well aware of due to our discussions regarding this fact. Also during my discussions with the client we discussed asset allocation and settled upon as moderately conservative for the large retail account, moderate for the inherited IRA and aggressive for the Roth as it represented only about 2.5% of the client's overall assets. The client was very aware of this strategy and agreed to the differences in and in the time horizon regarding the asset allocation between the 3 accounts. Not only did I discuss all facets of these accounts including the risks associated with them but I followed up with the clients as I was implementing the strategies and also when they requested a reduction of risk in the IRAs, I acted upon that request immediately. These allegations are false and I believe that once all the facts are reviewed, I will be cleared of any wrong doing.
