About BrokerCheck®

BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. - **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: Without admitting or denying the findings, Rodriguez consented to the sanction and to the entry of findings that he converted approximately \$200,000 from an elderly and legally blind customer and used these funds to purchase two apartments in Rodriguez' name. The findings stated that when the customer's lease on his apartment was terminated, Rodriguez offered to assist the customer with locating and purchasing a residence. Rodriguez purchased an apartment for approximately \$70,000 in the Bronx, New York using the customer's funds. The apartment was supposed to be purchased in the customer's name. Unbeknownst to the customer, Rodriguez was the sole beneficial owner of the apartment. The customer was not able to see or read the documents due to his disability. Through



these actions, Rodriguez converted the customer's funds. Although Rodriguez legally owned the apartment, the customer moved into the apartment and lived there for several years. Rodriguez also recommended that the customer open a joint bank account with Rodriguez so Rodriguez could assist the customer with paying his bills. The joint banking account was opened at a non-affiliated bank with an initial opening balance of approximately \$42,000. The joint bank account was funded exclusively by the customer and reached a balance as high as approximately \$153,000 in September 2013. The funds in the joint bank account were intended to be used solely for the benefit of the customer and were only to be withdrawn with the customer's permission. After a grocery store within walking distance of the apartment where the customer was residing closed, Rodriguez recommended that the customer purchase a second apartment. Rodriguez purchased a second apartment in Yonkers, New York for approximately \$130,000 using the customer's funds from the joint banking account. The apartment was supposed to be purchased in the customer's name. Unbeknownst to the customer, Rodriguez was the sole beneficial owner of the apartment. The customer was not able to see or read the documents due to his disability. The customer did not reside in this apartment. Rather, without the customer's authorization or consent, Rodriguez began renting the apartment to tenants and collected and retained the rent. Through these actions, Rodriguez converted the customer's funds.
