- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

Allegations: Without admitting or denying the findings, Hind consented to the sanction and to the entry of findings that he misappropriated funds by obtaining double payment on his member firm's paychecks. The findings stated that Hind misappropriated the funds by depositing the paychecks via a mobile application into his checking account and also cashing the physical copies of those same checks at check cashing centers. Hind previously received paychecks from the firm via direct deposit to his checking account. However, Hind notified the firm that he had closed his checking account and wished to receive physical paychecks going forward. The firm issued Hind physical paychecks on three separate dates, totaling \$5,109.15. Through Hind's strategy, he received double payment from each of the three paychecks. Because each paycheck had already been deposited and paid, the paychecks were returned unpaid to the check cashing centers, resulting in losses to the check cashing centers.
