- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

IN CONNECTION WITH THE APPLICATIONS, ZUMBRUM FORGED THE CUSTOMER'S SIGNATURES AND SUBMITTED A FALSE ORAL SWAB SAMPLE. ZUMBRUM'S REQUEST WAS AN EFFORT TO MEET SALES PRODUCTION GOALS AND NOT BASED ON THE CUSTOMER'S INSURANCE NEED. ZUMBRUM OFFERED TO PAY FOR THE POLICIES. THE CUSTOMER DID NOT AUTHORIZE THE PURCHASES. IN SPITE OF NOT RECEIVING AUTHORIZATION, ON JUNE 3, 2010, ZUMBRUM SIGNED THE CUSTOMER'S NAME ON THE APPLICATIONS FOR THE CUSTOMER AND HER MINOR CHILD WITHOUT THE CUSTOMER'S KNOWLEDGE OR CONSENT. ZUMBRUM ALSO FALSELY ATTESTED THAT HE WITNESSED THE CUSTOMER'S SIGNATURES. ZUMBRUM PAID THE PREMIUMS ON THE POLICIES. ON AUGUST 1, 2010, ZUMBRUM COMPLETED A FORM FOR THE SUBMISSION OF AN ORAL SPECIMEN TEST (OST) TO HIS MEMBER FIRM'S INSURANCE AGENCY IN CONNECTION WITH THE CUSTOMER'S TERM LIFE INSURANCE APPLICATION. ZUMBRUM SIGNED THE CUSTOMER'S NAME ON THE FORM WITHOUT HER KNOWLEDGE OR CONSENT. ZUMBRUM SUBMITTED AN



ORAL SWAB TO THE INSURANCE AGENCY IN THE CUSTOMER'S NAME AND REPRESENTED THAT IT CONTAINED A SAMPLE FROM HER WHEN IT DID NOT IN FACT CONTAIN AN ORAL SPECIMEN FROM HER. ZUMBRUM REFUSED TO APPEAR AND PROVIDE TESTIMONY AS REQUESTED BY FINRA.
