- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

**Broker Statement**

THE FA ADVISED THAT SHE AND THE CLIENT SPOKE ON FRIDAY, OCTOBER 3RD, AND THE CLIENT AGREED TO MEET WITH AN ANNUITY CONSULTANT TO DISCUSS THIS MATTER. THE FA, CONSULTANT AND THE CLIENT HAD A CONFERENCE CALL ON FRIDAY AFTERNOON AND THE CLIENT AGREED TO AN APPOINTMENT ON THURSDAY, OCTOBER 9TH. DURING THIS CONVERSATION, THE FA ADVISED THAT SHE WOULD LEAVE THE ACCOUNT ALONE, UNTIL THIS MEETING, AND THE CLIENT AGREED. THE FA RECEIVED A FAX ON MONDAY MORNING INSTRUCTING HER TO LIQUIDATE THE ACCOUNT. SINCE THE FA COULD NOT ACCEPT THESE INSTRUCTIONS, SHE IMMEDIATELY CALLED THE CLIENT TO ADVISE THAT SHE COULD NOT ACCEPT THESE INSTRUCTIONS AND TO CONTACT HER IMMEDIATELY. THE CLIENT DID NOT CONTACT THE FA UNTIL AFTER THE CLOSE OF BUSINESS ON MONDAY, OCTOBER 6TH. AT THAT TIME, THE FA STATED THAT THE MUTUAL TRADES WOULD NOT FILL UNTIL THE CLOSE ON TUESDAY. THE FA ALSO CONTACTED THE CLIENT SEVERAL TIMES DURING THE WEEK WITH THE BIDS ON BONDS THAT WERE HELD IN THE ACCOUNT. EVERYTHING WAS LIQUIDATED IN THE CLIENT'S ACCOUNT BY OCTOBER 9TH. THE CLIENT'S CLAIM WAS DENIED.
