FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

THIS COMPLAINT IS WITHOUT MERIT. THE CLIENTS COMMUNICATED A MODERATE RISK PROFILE TO ME AS A RESULT OF DETAILED FINANCIAL PLANNING DONE WITH THE CLIENTS PRIOR TO INVESTING. THE MODERATE RISK PROFILE IS DOCUMENTED IN MULTIPLE PLACES: THE DATA GATHERING WORKSHEET, THE FINANCIAL PLAN DOCUMENT REVIEWED WITH THE CLIENTS, THE INVESTMENT PROPOSAL SIGNED BY THE CLIENTS, AND THE QUARTERLY PERFORMANCE REVIEWS DELIVERED TO AND DISCUSSED WITH THE CLIENTS. ALL TRADES WERE DISCUSSED WITH THE CLIENTS AND APPROVED BY THE CLIENTS PRIOR TO PURCHASING SECURITIES. ACCOUNT REVIEWS WERE CONDUCTED WITH THE CLIENTS MULTIPLE TIMES PER YEAR SINCE 2010. THE VOLATILITY OF VARIOUS ASSET CLASSES AND THE NEED FOR A LONG-TERM HORIZON WHEN INVESTING IN SECURITIES WAS PART OF THESE CONVERSATIONS. UBS SETTLED THIS CASE FOR A MINIMAL AMOUNT TO AVOID THE COST OF ARBITRATION. I MAINTAIN MY POSITION THAT THE CLAIM IS WITHOUT MERIT AND THERE WAS NO WRONGDOING ON MY PART OR ON THE PART OF UBS.
