BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at <https://www.adviserinfo.sec.gov>. - **Are there other resources I can use to check the background of investment professionals?**

Allegations: CLIENT INDICATES THAT AS PART OF A REPOSITIONING OF MANY ACCOUNTS TO THE FIRM, AN ANNUITY WAS MOVED FROM A 'QUALIFIED TO A NON-QUALIFIED' PLAN. THE CLIENTS WERE UNAWARE THAT THIS TRANSFER WOULD CAUSE PENALTIES AND TAXES. THE CLIENT INDICATES THAT HAD THEY KNOWN OF THE TAXES AND PENALTIES, THEY WOULD NOT HAVE MADE THE MOVE. IT WAS NOT UNTIL THEY MET WITH THE CPA TO SIGN THEIR TAX FORMS THAT THEY WERE ALERTED TO THE SIGNIFICANT TAXES AND PENALTIES. THE CLIENT IS REQUESTING THE TRANSACTIONS BE REVERSED.

Broker Statement

THE FINANCIAL ADVISOR CONDUCTED A REVIEW OF THE CLIENTS' NON-QUALIFIED ANNUITY AS WELL AS OTHER INVESTMENTS PRIOR TO MAKING A RECOMMENDATION. THE ANNUITY ISSUER, NOR THE CLIENTS, MADE THE ADVISOR AWARE THAT THE ANNUITY HAD BEEN FUNDED BY A 1035 EXCHANGE. WHILE THE FINANCIAL ADVISOR EXPLAINED TAX IMPLICATIONS AND PENALTIES INVOLVED IN LIQUIDATING THE ANNUITY, BOTH THE ADVISOR AND CLIENTS BELIEVED IT WAS ON AN APPROXIMATE \$2,000 GAIN. THE FIRM HAS SETTLED WITH THE CLIENTS IN THE AMOUNT OF \$13,646.00 TO OFFSET THEIR UNEXPECTED TAX BURDEN.
