FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: FINRA RULES 2010, 8210, NASD RULES 2110, 3040: BIANCULLI ENTERED INTO AN INFORMAL AGREEMENT WITH TWO OTHER BROKERS AT HIS MEMBER FIRM TO SHARE IN COMMISSIONS RELATING TO UNDISCLOSED PRIVATE SECURITIES TRANSACTIONS, WHICH PURPORTED TO ADVANCE CASH TO MERCHANTS IN EXCHANGE FOR THE MERCHANTS' FUTURE CREDIT CARD RECEIVABLE. IT WAS IN FACT A PONZI SCHEME. BIANCULLI FAILED TO PROVIDE HIS FIRM WITH WRITTEN NOTICE OF HIS INVOLVEMENT IN AN UNAPPROVED PRIVATE SECURITIES TRANSACTION. WITHOUT INFORMING HIS FIRM ABOUT THE TRANSACTION, BIANCULLI HELPED THE TWO BROKERS WITH SERVICING A CUSTOMER'S INVESTMENT. BIANCULLI CALLED ONE OF THE BROKERS TO DISCUSS THE INVESTMENT WHEN THE CUSTOMER WANTED THE INTEREST PAYMENTS WIRED TO A SPECIFIC ACCOUNT. ALSO, BIANCULLI CONTACTED THE SAME BROKER ON THE CUSTOMER'S BEHALF TO HANDLE THE CUSTOMER'S INQUIRY INTO THE LATE INTEREST PAYMENTS. BIANCULLI PROVIDED FALSE AND MISLEADING INFORMATION TO FINRA DURING A SWORN ON-THE-RECORD TESTIMONY. FURTHER, BIANCULLI PROVIDED FALSE AND MISLEADING STATEMENTS TO HIS FIRM IN RESPONSE TO A COMPLIANCE QUESTIONNAIRE DISTRIBUTED BY THE FIRM INQUIRING INTO THE



SCHEME. BIANCULLI DENIED MEETING ANY OF THE OWNERS OR PRINCIPALS OF THE PRIVATE SECURITIES TRANSACTION AND FAILED TO DISCLOSE HIS PARTICIPATION IN THE CUSTOMER'S INVESTMENT.
