#### What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
  qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
  reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
  same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

This client received all disclosures to include the Illiquid Investment Acknowledgment as well as the prospectus. He signed all documents including the application with disclosures and authorized his check made payable to the security company. The entire processing also had to go through the broker dealer compliance processing team before being forwarded for placement to the investment company. The client had two previous illiquid investments in REIT's with the NYRR and the Griffin Capital Health Care programs both paid double digit returns to him prior to his investing in this program. Some of those funds were used in the next program as memory serves. This goes back to 2014 or 2015 about 8 years ago. The investment is still active and pays dividends however is illiquid to this date.
