BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Broker Statement

WE HAVE REVIEWED THE ACCOUNT AND WE HAVE BEEN IN CONTACT WITH THE FA REGARDING THE CLIENT'S CONCERNS. THE EXXON (XOM) TRANSACTION IN QUESTION WAS PLACED ON MAY 24, 2011. IT IS OUR UNDERSTANDING THAT THE FA MET WITH THE CLIENT AT HER HOME TO ASSIST WITH THE NECESSARY STEPS TO HAVE THE ASSETS DISTRIBUTED FROM HER HUSBAND'S EXXON RETIREMENT. OUR RECORDS REFLECT THAT ASSETS WERE TRANSFERRED INTO EDWARD JONES. ACCORDING TO THE FA HE MET AT THE CLIENT'S HOUSE TO DISCUSS INVESTMENT GOALS AND OBJECTIVES AND IT WAS INDICATED THAT SOCIAL SECURITY AND EXXON PENSION WOULD COVER BASIC LIVING EXPENSES AND A FEW SHORT-TERM EXPENSES. AT THE TIME OF THE MEETING THE CLIENT INDICATED THAT THEY WOULD LIKE ADDITIONAL INCOME TO ASSIST WITH YEAR-END TAXES AND OTHER RECURRING COSTS. THE FA CONTENDS AT THE TIME OF THE APPOINTMENT HE EXPRESSED THE RISK OF HAVING A LARGE PERCENTAGE OF NET WORTH IN ONE HOLDING (XOM), THE IMPORTANCE OF DIVERSIFICATION/ASSET ALLOCATION, THE POSSIBLE ALTERNATIVES TO REBALANCE THE PORTFOLIO, AND THEN HE MADE RECOMMENDATIONS TO REPOSITION SOME ASSETS TO PROVIDE THE CLIENT WITH THE ADDITIONAL INCOME. AT THE TIME OF THE TRANSACTIONS, THE CLIENT WOULD HAVE RECEIVED TRADE CONFIRMATIONS AND A MONTHLY STATEMENT REFLECTING THE ACCOUNT ACTIVITY. BASED UPON OUR INVESTIGATION, IT IS OUR OPINION THAT THE CLIENT PROVIDED THE FA AUTHORIZATION TO PLACE THE SELL OF XOM AND PURCHASE OF THE FIXED INCOME UIT. IN ADDITION, IT APPEARS THAT THE CLIENT RECEIVED THE NECESSARY INFORMATION TO MAKE AN INFORMED DECISION. COMPLAINT DENIED
