BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

Employing firm when activities occurred which led to the complaint: EDWARD JONES

Allegations: Claimants allege that as a result of a Transfer on Death Designation prepared by registered representative and Edward Jones, the Estate, the Trust, and the Estate and Trust Beneficiaries have been required to commence probate proceedings as well as legal action to attempt to bar a beneficiary from obtaining a larger share of Decedent's property than Decedent intended to give or bequeath to him from her Edward Jones Account or from the Trust or Estate. Claimants allege that they were assured that the new account established in August 2018 would allow the account holder (now deceased) to access funds as determined necessary but otherwise would not negatively affect her estate plan. Claimants allege that the new account and related account activities did not match Decedent's intent to maintain her estate plan. Claimants allege that certain activities regarding the account amount to negligence, breach of fiduciary duty, failure to meet the standard of care for an investment advisor. It is claimed that Edward Jones is vicariously liable for the actions of registered representative as well as breaching an independent duty to properly supervise.
