BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at <https://www.adviserinfo.sec.gov>. In the alternative, you may search the IAPD website directly or contact your state securities regulator at <http://www.finra.org/Investors/ToolsCalculators/BrokerCheck/P455414>.

- **Are there other resources I can use to check the background of investment professionals?**

Broker Statement

THE 10 DAY LAPSE IN MY INSURANCE LICENSE OCCURRED BECAUSE THE TWELVE DOLLARS AND FIFTY CENTS (\$12.50) RENEWAL FEE PAID EVERY TWO YEARS TO THE DEPARTMENT OF INSURANCE WAS UNKNOWINGLY NOT PAID ON MY BEHALF. THE LICENSING STAFF AT MY EMPLOYER'S OFFICE AND I WERE UNDER THE IMPRESSION THAT ALL MY CONTINUING EDUCATION FEES AND REQUIREMENTS HAD BEEN MET WELL IN ADVANCE TO RENEW MY LICENSE FOR THE UPCOMING YEAR. I WAS NOTIFIED ON AUGUST 11, 2011 THAT BECAUSE THE \$12.50 FEE HAD NOT BEEN PAID, MY LICENSE DID NOT RENEW EFFECTIVE AUGUST 1, 2011 CAUSING A 10 DAY LAPSE. I IMMEDIATELY CALLED THE SC DEPARTMENT OF INSURANCE AND MY EMPLOYER PAID THE \$12.50 FEE + \$50 LATE FEE TO RENEW MY LICENSE. THIS PAYMENT RENEWED MY LICENSE IN GOOD STANDING EFFECTIVE AUGUST 11, 2011. I INFORMED THE DEPARTMENT OF INSURANCE THAT I HAD WRITTEN 13 AUTO & HOMEOWNERS INSURANCE POLICIES DURING THE 10 DAY PERIOD THAT MY LICENSE HAD UNKNOWINGLY LAPSED. A \$50 FEE PER POLICY WRITTEN WAS PAID (\$650 TOTAL) TO CLOSE THIS MATTER.
