**Broker Statement**

Client was informed of all fees and risks associated with the annuity product including the six-year surrender schedule. The discussion was documented at account opening. Client exited the annuity six months later and generated a 13% return after the surrender fee. Complaint was initiated because the client received the check from the annuity carrier one day later than the expectation set by the annuity carrier. The complaint was thoroughly investigated because of the serious nature of the allegation and was denied based on the circumstances stated above.
