- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

<b>Broker Statement</b>	This accusation is ridiculous. Representative Caruso has provided to FINRA evidence of significant communication with this employer during the period in question, refuting their argument. Representative Caruso was in the process of travelling to obtain the information requested by this employer when the employer took this action. And the allegation of a short period of non-communication is not a



violation of "investment-related statutes, regulations, rules, or industry standards of conduct". FINRA is improperly requiring that representative Caruso check this box, which creates a false impression of a violation of industry rules to the general public. FINRA will then charge a large fee for reviewing this filing that they require and that should not have to be made. We have addressed this matter with the Disclosure Review Department at FINRA, which we had to chase down over a three week period after our initial filing to get a response, even though it claimed in its automated response to us that it would handle this matter within "three to five business days". Representative Caruso had to remain unemployed during this period. FINRA refuses to address the evidence provided or state the specific violation of industry rules that necessitates this filing.
