- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

Allegations: This customer dispute/claim is a "products" case wherein CLAIMANTS allege that RESPONDENT [Centaurus Financial] did not conduct reasonable due diligence on an investment that they approved for their advisors & clients to purchase. The claimants' original investment was made in April 2019 and the investment company filed for chapter 11 bankruptcy in 2022. Their claim of 'unsuitability' is being made in arrears due to the investment company's recent financial challenges, which were non-existent & therefore unknowable at the time of their investment.

Broker Statement

I unequivocally disagree with the inaccurate summary of allegations provided here by my former broker/dealer firm: Centaurus Financial. Per the Statement of Claim that was filed, the claimants did not sue me for breaching my fiduciary duty and I was not named as the respondent party of their claim. The claimants were specifically arguing that this was a "defective product" type case and were suing Centaurus Financial. This means that they were contending Centaurus Financial failed to conduct proper due diligence and research when they approved this product and made it available to their advisors and clients. As a registered representative of Centaurus at the time of this transaction, I was only permitted to offer investment products that were approved by Centaurus Financial and was never involved in the broker dealer's product review/approval processes. In addition to the aforementioned errancy regarding breaching my fiduciary duty, the claimants were initially seeking a dollar amount of \$150,000 as a return of their initial investment amount. This summary inaccurately lists a claim amount of \$230,000; it appears that Centaurus was permitted to 'bundle' an additional \$80,000 "damage" claim amount, from a separate & unrelated financial advisor & client. I would be happy to provide a copy of the Statement of Claim (with confidential information redacted) to any party who wishes to review the actual claim details provided therein. My desire was to see Centaurus contest the claim due to its numerous inaccuracies & errant claims; despite my efforts to provide Centaurus with substantial substantive information to support the refutation of this claim, Centaurus chose to 'settle' it, without my involvement, rather than to contest/arbitrate the case.
