- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Employing firm when activities occurred which led to the complaint: Woodmen Financial Services, Inc.

Allegations: Client, [REDACTED], claims that Registered Representative Paul Winters did not provide sufficient or alternative product offerings at the time [REDACTED] purchased his Jackson National Elite Access variable annuity (inherited IRA). After reviewing a recent quarterly statement which showed his investment was down one percent (1%) during the quarter, [REDACTED] claimed that he was looking for low-risk investments without risk to his principle. Representative Paul Winters had [REDACTED] complete the Woodmen Financial Services, Inc. ("WFS") New Account Form which asks [REDACTED] to indicate his investment objective and risk tolerance. On the form, [REDACTED] marked that his investment objective was "Moderate-Conservative" with a risk tolerance of five (5) on a scale of one (1) to ten (10). On the risk tolerance scale, the products indicated underneath a "5" are "investment-grade funds, municipal bond funds, and value oriented funds" for which [REDACTED] Jackson National Elite Access Variable Annuity, which is invested in the Jackson National PIMCO Credit Income Fund and the Conservative Allocation Fund, would be categorized.

Further, Mr. Winters stated that other investment options were presented to [REDACTED] at the time of sale, but based on [REDACTED] tax and investment needs, the Jackson National product was selected.

Based on the Firm's review of this matter, the Firm denied the complaint.
