About BrokerCheck®

BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations:	Jenney was named a respondent in a FINRA complaint alleging that he failed to provide information and documents requested by FINRA, and further failed to appear and provide testimony FINRA requested, on two occasions, in connection with its investigation into his conduct as set forth in a Form U5. The complaint alleges that Jenney's member firm had filed a Form U5 stating that he had been discharged after allegations that he provided investment advice on a product not available through the firm. Jenney's failure to provide the requested information, documents, and testimony prevented FINRA from learning about whether he had engaged in private securities transactions while at the firm, and questioning him about his denial that he had done so. It also denied FINRA the opportunity to further test Jenney's denial through the review of documents that FINRA requested



but he never provided. Because the requests were specific to Jenney, only he could provide FINRA with the information, documents, and testimony that it needed to undertake its investigation in furtherance of its regulatory mission.

Regulator Statement

Default decision rendered April 9, 2020. The sanction was based on findings that Jenney failed to produce documents and to appear and provide on-the-record testimony during FINRA's investigation into the circumstances that led to his termination from his member firm. The findings stated that the firm submitted a Form U5 terminating Jenney's employment and disclosing that he provided investment advice on a securities product not offered by the firm. The decision became final May 7, 2020.
