Firm review of transaction history indicates that trades in question were unsolicited and client requested liquidation of 87% of his account value in order to raise cash for an outside investment. Although there was a realized loss as a result of the client's liquidation request, these transactions were not recommended by the Advisor, losses were used to offset capital gains and the overall account was profitable during the time it was under management. Complaint denied.
