- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Broker Statement

I was divorced in 2014. Per my divorce, anything pertaining to the 1352 Tristram Cir residence, I'm not liable for anymore. My ex-wife didn't qualify for the home on her own, so the mortgage company left my name on it. The property is a condo is required to have monthly associate fees paid to maintain it. My ex-wife was making payments to the company's website toward the end of the month, within the time period allowed to make the payment and be considered "on time". The company's website has a delay in it's processing of the payment and because of this it's showing the payment being made after the allotted time period for being on time, therefore showing late. The property manager acknowledged that the website does in fact have this glitch, and although proven by my ex-wife with bank statements showing the payments to the website on time, the property manager and their legal department are not willing to release the lien until there is satisfaction of the legal



fees and lien release fees, but they are willing to waive the late fees. My ex-wife is currently seeking legal counsel as she believes she's not liable for any of the fees. But because my name is still on the deed and the mortgage, I've been attached to this litigation. Again, per my divorce decree, the house became sole property of my wife and I was released of any obligation to it.
