- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and

**Broker Statement**

This matter was the subject of a Class Action lawsuit filed in the U.S. District Court, Southern Dist. of Florida, Case No. 1-10-cv-23235-WMH and should have been barred under New Jersey's Entire Controversy Doctrine. The Superior Court of New Jersey, refused to vacate the default judgment and refused to grant me leave to file an Answer, Counterclaim, and Third-Party Complaint against the Plaintiff and JP Morgan Chase & Co.. d/b/a Chase Manhattan Bank USA, N.A. I paid for "Payment Protection" credit insurance and Chase refused to honor my claim to have my balances paid in full when I became unemployed and financially unable to pay my credit card bill.

### Broker Statement

I have never been personally served with a Complaint and Summons in this matter. I have never contracted to do business with ERSA. I do not acknowledge nor admit to owing any debts to ERSA Court Reporters. I never hired ERSA nor have I ever authorized anyone acting on my behalf to hire or contract with ERSA. I dispute this debt and intend to petition the court to vacate .

In Dec. 2008, I hired a New Jersey attorney to represent me in an employment discrimination lawsuit filed in New Jersey state court. I paid my attorney a \$10,000 Retainer fee and any fees for depositions or transcripts were supposed to be paid out of the retainer fee. However, again, neither I nor my attorney contracted to do business with ERSA nor did we order or agree to pay any services or rendered by ERSA Court Reporters in connection to the New Jersey lawsuit.
