About BrokerCheck®

BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

My name is Patrick Foley. My wife, [spouse], purchased and owns 100% of the stock of Canyon River Dental in 2008 and is 100% shareholder and owner. Canyon River Dental was listed on my OBA form, with Merrill, even though I had no ownership in the company, as I had previously worked there as an employee. In June 2017, My Merrill Lynch compliance manager approved that I assist my wife with Canyon River Dental in terminating an employee who was embezzling funds from the corporation. In Sept 2017, [third party], a family friend since 2002, and a customer at Merrill with me since the previous month, lent Canyon River Dental money for cash flow purposes, due to the embezzlement issues. This loan was made to Canyon River Dental Corp. and not to me.
